the constitution of burkina faso aims at ensuring the equal protection of the rights of all burkinabe men and women. nonetheless, women face discrimination and inequality in all areas of social, political and economic life, including in education, health and employment. women in burkina faso have limited access to land, and cannot sign contracts. under the law of inheritance, women typically receive a smaller share of a deceased spouse's property. the constitution of burkina faso establishes equal rights for men and women. however, most women are subjected to various forms of discrimination, particularly when they seek to access or remain in higher education. in addition, they are very often the target of physical violence, often perpetrated by their husbands, brothers or sons. certain provisions of the legal and administrative framework reinforce gendered stereotypes and result in discrimination and violence against women. amongst women and men in burkina faso, women hold an inferior position in all areas of public and private life. yet they face discrimination and are denied a say in all areas of society. the constitution guarantees equality between men and women, but a number of legislative and regulatory provisions, including those governing employment and political participation, are still discriminatory. the constitution also states that access to higher education must be open and equally accessible to women and men. in fact, in practice, it is still not. burkina faso's 2001 constitution establishes the equality of women and men before the law. the protection of women and children act (law n°2004-123 of 18 september 2004) reiterates this principle. yet, women and girls continue to be subjected to harassment, abuse and violence. the constitutional court reaffirmed the principles of equality in relation to the fundamental rights of citizens. however, its decision in the case of 'kanteri' and 'kamar' v. state (c-247/04) (2004) has not been applied. the country must follow up on this decision, as it is a cornerstone of the new constitution.

constitution of south sudan was adopted in 2011. it is modelled on that of sudan and provides for equality of rights between men and women. two constitutions have been in force since the countrys independence in 2011. the first one came into effect in 2011 but was suspended after the coup against omar bashir; the

second was adopted in 2016. south soudan is a diverse and highly-militarised society. each of the major ethnic groups has a separate system of customary law, known as the ju-ju. in spite of these impediments, the new constitution is an achievement for women as it provides them with equal rights to men. the

constitution of burkina
faso was adopted in july
2015. it affirms that men
and women are equal in
rights and duties, and
provides that anyone has
the right to marry a
person of his or her
choice. the new
constitution provides for
equality of opportunities
and provides for women
to receive an education
and to practice their

profession. it also
guarantees women equal
rights in sexual relations.
however, most of the
countrys problems stem
from its social traditions.
